


2. AIMS AND OBJECTIVES OF THE TRUST:

1. To arrange for feeding of poor and needy devotees through Dasoha. To establish run Kalyan Mantap and perform marriages of poor and deserving people, construct temple and worship and give assistance for such, to control regulate manage the entire administration of Devasthan including moveable and immoveable property.
2. To promote standard of education and to establish institutions from primary level to post graduate level courses in all branches of knowledge and sports and Gymnastics.
3. To grant relief during the calamities, such as Earthquake, Cyclone, floods, fires, draught pestilence and other occasions of calamities of similar nature and to give and receive donations, subscriptions and contributions for such purpose.
4. To construct and manage Bal Vikas Mandirs, Balwadies, Kalyan Mantaps, Community Halls, General Hospitals, Hostels for Women and children and working women and homes for the aged and to implement social welfare and security schemes and measures.

14. To raise and borrow loans and to accept deposits.
15. To invest funds which are not immediately require by the trust as may be decided from time to time.
16. To accept unconditionally on proper terms and conditions gifts of moveable including cash and immoveable property etc.,



II. THE TERM OF OFFICE BEARERS OF THE TRUST:

1. The founder trustee, president shall have the term for office till his death after his death any one of his legal heirs will act as the president.
2. The other office bearers will hold their office for a period of three years. After the completion of the term, the president shall have the discretionary power to appoint the vacant post of the office bearer or he can continue the any posts of office bearers at his choice from among the board of trustee the same has to be approved by 2/3rd majority of member trustee.
3. The member trustee and office bearers are not entitled to any salary or remuneration etc., but they are entitled for T.A. and D.A. charges for the work done towards the fulfillment of the aims and objectives of the trust.

III. WHEREAS, the President shall be the responsible person of the trust and shall have full financial power to sign bills, recover, admit or remove tenants for this purpose file suits execute distress and carry out the repairs and interest warrants, cheques and receipts and to do other acts for recovering the income money revenue and fund of the trust.

Whereas the President is the supreme authority of the trust striving for the over all development and fulfilling the objects and aims of the trust.

Whereas the President shall be the responsible person in the trust and shall manage the activities and programs of the trust. However some specific functions will be delegated to the other trustees in the interest of the trust as regards development aims and objects specified under the trust.

Whereas the Secretary under the directions of the President shall be in charge of the Chief correspondent of the Trust and responsible for the safe custody of all records relating to the administration of the trust properties and maintenance of regular records of all meeting and proceedings. Besides this controlling, supervising and disbursing authority shall be vested with president and he who in turn shall be responsible person to maintain, watch, accord sanction, release and approve financial matters, and also deal with appointment of heads of faculties including administrative and ministerial staff and other ancillary and incidental affairs of the object of the trust shall be managed, controlled, supervised in consultation with the trustees.

Whereas Secretary should prepare the budget and estimates of every year in consultation with the President and trustees. He shall also be the responsible person in constituting the committees and such committees such as advisory committee, appointment committee, finance etc., in consultation with the President.

Whereas the treasurer shall collect donations from the public & issue valid receipt and remit the same with the bank account and maintain the following finance books such as keeping up to date accounts of the trust, preparing the budget and estimates of every year in consultation with the trustees, informing the exact financial position of the trust time to time to the President and trustees and audit every year through chartered accountant or tax practitioner.

The executive body of constitute shall meet once in a month.

2/3rd of the trustees shall constitute the quorum.

The trust shall have permanent and perpetual office having seal of its own and shall continue from generation to generation upholding the objects and the aims for which the trust is created.

The trust shall have power to accumulate the income out of the annual income of the trust from time to time such accumulation of incomes shall be made as per the provisions of the Income Tax Laws in vogue.

The trust shall have power to utilize not only the income but also the corpus or any part of the corpus of the trust for any of the objects.

The President shall have power to constitute sub-committee on education, administration, development, publicity, publication, works and finance, women and children foreign affairs, cultural matters and such other subjects which he deems fit and such sub committees shall directly function under the president.

That if any association of Society or trust or institution at any time herein after offer to aid or amalgamate or merge with the trust whether by transfer of any immoveable or moveable property or of Government or other securities or payment of cash in aid of any of the objects, it shall be lawful for the Board to accept the same upon such terms and conditions not inconsistent with any of the objects of the trust as the trust may determine.

The trust shall grant affiliation to any association or society or trust interested in being affiliated or associated with the trust and the affiliation fees stipulated by the trust time to time and the affiliated institution shall receive guidance in its activities and solutions of its problems.

The trust shall associate with the international agencies working for the cause of peace, friendship and co-operation and development of less privileged people aid or financial assistance from such agencies which are permitted to aid or offer financial assistance in accordance with the rules made by the Government of India or any other authority.

Every question or resolution coming before the trust shall be decided by the majority of the trustees present and voting on the issue in case of equality of votes the president shall have a casting vote. The passing of the resolution or an issue shall also be done by circulation being signed and approved by the Trust.

The account shall be operated jointly by the President and Secretary. All transactions shall be made through the nationalized banks, schedule Banks.

The trust may raise or borrow money required for the purpose of carrying out the objects of the trust and for carrying out any repairs to immovable property for time being and from time to time belonging to trust upon mortgage or pledge by the trust properties or any part thereof with or without any security and at such rate of interest and on such terms as to the repayment or otherwise the trust deems fit.

That every trustee shall indemnify the trust for any loss caused to it by his or her willful negligence or misrepresentation.

The trust formed shall be irrevocable and it shall be revoked as per the provisions of the Indian Trust Act 1882.

The trust is governed by the provisions of the Indian Trust etc., 1882 in the matter of its creation, functioning and administration of its institutions and its other affiliated institutions.

The funds of the trust shall be invested in the modes of specified under the provisions of Sc. 13 (1) (d) read with Section 11 (5) of the Income Tax Act 1961.

The trustee shall be removed from the Trust in case the trustee acts in contravention of the aims and objects as stated above. In the following circumstances, the trustee is deemed to be ceased from its existence.

The President of the trust shall have the power to remove any trustee named above who acts against the interest and aims and objects of the trust with seven days show cause notice and such removal shall be ratified by 2/3rd majority of the board of trustees.

The members of the board of the trustees shall not be less than 5.

That the powers of the trustees shall be exercised as to ensure that the income of the trust would be exempt under section 11 of the Income Tax Act 1961 as read with Section 12, 12A amended from time to time. Provided further that any or all these powers can be exercised by any trustee or any group of them on being so authorized by the Board of Trustees.

The official year of the trust shall be April 1st to 31st March every year.

All the official correspondence shall be made in the name of the President or the Secretary of the trust.

In case the trust is not able to function for any reason or the Board of the Trustees decided by the majority of not less than three fourth of the total number of trustees to wind up the trust, the assets of the trust after meeting the liabilities of the trust shall be transferred to another trust or society or association selected by the Board of trustees, which similar objects as those of this trust and has been recognized as Public Charitable Trust and Section 11, 12 and Sec. 80 (G) of the Income Tax Act 1961.
